#### 1. Call to Order

Kukjin Chun, Region 10 Director, called the meeting to order at 8:00 am, Friday, 11 August 2017. He welcomed all the participants to the meeting.

3. Review of Program and Agenda

### 4. Address of Director by Kukjin Chun

He made the following observations:

- Congratulations to MGA Awards recipients.
- Introduced IEEE in general: members, organizational governance, geo units,
- R10: sections and members, 16 countries with sections, 4 countries with only subsection, countries with small number or no members.
- Areas of focus: establishing new IEEE Geo units, student retention, continuation to YP, conference paper quality, industry membership, entrepreneurship
- Division of works in R10
- 50 Yr celebration plan: commemoration book, meeting, celebration
- R10 in Sections Congress: grand celebration, panel discussion
- R10 traditions R10 tradition of 50% matching from sections, try to use your committee budget for at least 80%. Seek approval from OpCom for grants and awards, consider number of membership, cost of living and vitality for grants and awards. We will put efforts to revive inactive sections.
- 6. Approval of the minutes of the annual general meeting in March.

After circulation of the minutes before the meeting and revisions according to the feedback, the minutes were approved without discussion.

7. Sections Congress Recommendation by Stefan Mozar.

He presented on the R10 Sections Congress Recommendation. His presentation included the following:

- Top 3 selected by a committee of 5
- R10 recommendations: 1) Develop an incentive program for corporations to join IEEE as 'Corporate Member', 2) Improve IEEE service to industry professionals by offering reduced cost access to standards with the goal of increased industry member satisfaction.
- 8. Presentation on IEEE Operations by IEEE Executive Director, James Prendergast He presented on the operations of the IEEE. His presentation included the following:

  - Xplore usage
  - Client services in R10
  - IEEE-SA to Asia-related activities
  - IEEE global initiative for ethical considerations in artificial intelligence and autonomous systems
  - Standardization projects
  - IEEE Collabratec
  - IEEE medal & recognition recipients
