









### New U.S. Climate Law


- US\$370 billion package to promote domestic production of clean energy technology
  - Places the U.S. much closer to its goal of cutting global warming pollution in half by 2030
- Makes public money available for research into new climate innovations

## **Chips Act**

 Invests \$280 billion to bolster US semiconductor capacity, catalyze R&D, and create regional high-tech hubs and a bigger, more inclusive STEM workforce
